**DECLARATION OF EUGENE A. SPECTOR, ESQUIRE**

I, Eugene A. Spector, declare as follows:

1. I am a member of the law firm of Spector Roseman Kodroff & Willis, P.C. My firm is counsel to Caesars Pasta Products, a plaintiff in this action. I make this Declaration based on my personal knowledge. If called as a witness, I could and would competently testify to the matters stated herein.

2. This Declaration pertains to the hours worked by professionals in my firm, and the expenses incurred by this firm, during the period from January 2009 through February 2011. My firm has submitted to interim co-lead counsel in this case monthly reports setting forth the hours which this firm has devoted to work on this case for the foregoing period of time, and expenses incurred in connection with this firm's work on the case during that period. These monthly reports are, in turn, based upon records of time and expenses regularly maintained by my firm in the normal course of conducting its business.

3. At the direction of interim co-lead counsel, my firm has performed the following

tasks in this litigation: researched and drafted an opposition to a motion to intervene filed by Kroger, et. al., group of individual plaintiffs; conducted meet and confers regarding discovery matters with the Hillendale and Ohio Fuel defendants, reviewing discovery requests and obtaining and discussing proposed responses from defendants' counsel, attempting to resolve disputes concerning those discovery requests, communications with interim co-lead counsel regarding those meet and confers; reviewing amended complaints in connection with the meet and confers; participated in conference calls with interim co-lead counsel regarding discovery issues and meet and confers; prepared correspondence summarizing and reporting on the results of the meet and confers; prepared matrixes regarding ESI information from Hillendale; and meetings and correspondence regarding these assignments.

4. Attached as Exhibit A hereto is a chart setting forth: the attorneys from this firm who have worked on this case; the number of years that each such attorney has been admitted to the bar; the range of billable rates charged by each such attorney for work performed on this case; the total number of hours that each listed attorney has worked on this case and, with respect to paralegals and law clerks, comparable information as to the number of hours worked and their hourly rates.

5. Attached as Exhibit B hereto are the monthly lodestar reports which this firm has submitted to Interim Co-Lead Counsel for the Direct Purchaser Class Plaintiffs from the inception of this case through February 2011. The lodestar amount reflected in the reports attached hereto is for work assigned by Interim Co-Lead Class Counsel and was performed by professional staff at my law firm for the benefit of the Direct Purchaser Plaintiff Class. I have reviewed the lodestar reports attached hereto and can confirm that they are true and correct. All work reported by attorneys and paralegals on behalf of the Direct Purchaser Plaintiff Class in this matter was performed on a wholly contingent basis. The historical rates set forth in the monthly reports attached as Exhibit B are the applicable hourly rates in effect at the time work was performed. These rates are the same rates charged to hourly clients and, in addition, have been

approved by other courts in ruling on fee awards in other class action litigation in which my firm has served as counsel during the relevant time period. Other cases in which our January 2009 through February 2011 rates, or substantially similar rates, have been approved by other courts include:
